Dear Prospective Associate Degree of Nursing Student,

The faculty and staff of the Department of Nursing appreciate your interest in our Associate Degree of Nursing (ADN) program. This packet will help guide you through the application process and provide you with the information about our Admissions Criteria and Selection Process. Admission into the program is competitive. Applicants must meet the minimum requirements of Manhattan Area Technical College and the Department of Nursing to be considered for admission to the Associate Degree of Nursing program.

The ADN program at Manhattan Area Technical College is approved by the Kansas State Board of Nursing. It also holds accreditation with the **Accreditation Commission for Education in Nursing**, 3390 Peachtree Road NE, Suite 1400, Atlanta, GA 30326, 404.975.5000, <http://www.acenursing.org>. The accreditation process requires additional evidence of program quality, and accreditation is awarded after a thorough review of all of the aspects of the program. The nursing courses within the Associate Degree of Nursing program are delivered over two semesters. The nursing courses, plus prerequisite courses, may take a total of 3 to 4 semesters to complete, depending upon prior academic history.

The program begins in August and January each academic year. Individuals complete academic and clinical requirements to earn an Associate of Applied Science degree in Nursing. The applicant must have a Kansas recognized LPN License and must also show transcript evidence of completing prerequisites. **Manhattan Area Technical College PN students in the first semester of the PN program are given priority to enter the ADN program in August following PN graduation, if all bridge requirements are met.** The ADN graduate is then eligible to take the NCLEX-RN licensing exam; successful completion enables the graduate to seek licensure as a Registered Nurse (RN).

Your MATC Admissions Application as well as the required Selective Admission Application and the documents listed within must be received on or before February 1 for August entry and October 2 for January entry. Any exception to this date would be at the discretion of the Dean of Nursing Education and Health Programs or designee.

Enclosed is information that is critical for a successful application—please read the entire packet carefully. We encourage you to make an initial campus visit appointment by [scheduling online](#), for information about college admissions and the ADN program. The college website at <https://manhattantech.edu/TransferADN> also provides additional information.

Please review the contents of this packet to get an overview of the admission process. We encourage you to contact the admissions office at admissions@manhattantech.edu if you have questions.

It is the responsibility of the student to ensure that all required materials for application are received by the application deadline date. Reminder calls will not be made if something is missing or does not meet the criteria, and the application may be invalid. The responsibility for a complete and accurate application is the students. Any packets not meeting the above criteria will be reviewed at the discretion of the Dean of Nursing & Health Programs or designee and based upon program capacity.

Academic Criteria

To be considered for admission in the Associate Degree of Nursing program, applicants must meet the following criteria and submit all requested credentials and documentation:

To be given priority, prerequisite courses must be COMPLETED before THE APPLICATION DEADLINE to be considered for admission. Any exceptions to those standards are at the discretion of the Dean of Nursing and Health Programs or designee.

<p>Applicants must have completed the prerequisite courses with a grade of "C" or higher and a minimum GPA of 2.0. <i>*Course can be completed as one or broken up as two courses (must add up to a minimum of five (5) credit hours).</i> ^College Placement testing may be required to determine where you place in math and English. Consult your advisor for more information, and check well in advance of the semester when you plan to enroll in a math course.</p>			

The following criteria applies to **ALL** applicants:

- ✓ **Active Kansas recognized LPN license**
 - Applicants for the Associate Degree of Nursing Completion program must have an active Kansas recognized LPN license. Effective July 1, 2019, Kansas was the 30th state in the United States to be a member of the Nurse Licensure Compact (NLC). Refer to the [website](#) for a complete list of states that are current members of the NLC. If you have questions contact [Kansas State Board of Nursing](#). Make sure you hold an [active Kansas recognized LPN Licensure](#) status prior to submission of the online application.
- ✓ **Complete ADN Entrance Exam - ATI Anatomy & Physiology Assessment**
 - The ATI Anatomy & Physiology Assessment is a requirement for program entry. Practice exams can be purchased through [ATI's website](#). The test can be scheduled online through [RegisterBlast](#) and is called the "ADN Entrance Exam".
- ✓ **Complete Prerequisite Courses – Noted Above in Table #1**
 - Applicants for the ADN program must have completed prerequisite courses with a ***cumulative GPA of 2.0 or higher*** to be considered for admission. **It is highly encouraged to have all transcripts on file with the college prior to meeting with an academic advisor. Any grades of "P" will be reviewed for transfer credit at the Registrars discretion. For scoring purposes, a "P" will be awarded as a "C" (2 points).**
- ✓ **Submit Transcript from Practical Nursing Program to Registrar Office**
 - Applicants for the ADN program will be scored based upon their cumulative GPA of their Practical Nursing program. Students are required to have a ***cumulative GPA of 2.0 or higher*** to be considered for admission. Transfer courses must have a grade of "C" or higher.

The following criterion applies, **IF APPLICABLE**:

- ✓ **Test of English as a Foreign Language (TOEFL)**
 - Practical Nursing applicants whose primary language is not English must demonstrate English language proficiency before being accepted into the Practical Nursing program. The test used to measure English proficiency as set by Manhattan Tech, according to the KSBN requirements, is the Test of English as a Foreign Language (TOEFL):
 - Writing: 20; Speaking: 20; Reading: 19; Listening: 20

Non-Academic Criteria

The following criteria applies to ALL applicants:

Immunizations

These requirements are in place for the health and safety of Manhattan Tech ADN students and their patients. By contract with your academic institution, all students participating in patient care in this institution must meet the following health and safety requirements. All documentation must meet requirements at all times during a clinical course. **The immunization requirements must be current to apply to the ADN program and participate in clinical hours. Refer to the immunization exemptions below for more information.**

- 1) **Measles, Mumps, Rubella (MMR) Documentation**
 - a. Two (2) doses or proof of immunity by titer
- 2) **Varicella (Chickenpox)**
 - a. Two (2) doses or proof of immunity by titer
 - b. Will NOT ACCEPT HISTORY OF CHICKENPOX - Chickenpox is an immunization that is often incomplete. We can only accept proof of vaccination or a titer. We cannot take anyone's testimony that you had chickenpox, not even a physician. Make sure that you have either vaccines or a titer. Paperwork for a low titer will not be accepted.
- 3) **Tetanus, Diphtheria, and Pertussis (Tdap)**
 - a. One (1) dose taken less than 10 years ago
- 4) **Hepatitis B (Hep B)**
 - a. Three (3) doses or proof of immunity by titer. If your titer is low or no immunity, you should get the vaccine. Paperwork for a low titer will not be accepted. It could take up to 6 months to complete the series as required.
- 5) **COVID-19 Vaccination**
 - a. Pfizer-BioNTech COVID-19 Vaccine series of two doses 3 weeks (21 days) apart **OR**;
 - b. Moderna COVID-19 Vaccine series of two doses 1 month (28 days) apart **OR**;
 - c. Janssen COVID-19 Vaccine single dose

Immunization Exemptions

Manhattan Area Technical College does not require vaccinations. Manhattan Tech partners with multiple health systems and healthcare providers to provide clinical and programmatic experiences for our students; many of our clinical partners require all students to have received COVID-19 and other vaccines before their on-site experiences and training may begin. As a result, unvaccinated students could be precluded from participating in these activities, potentially impacting their ability to complete all program requirements. Students may seek a medical or religious exemption from a clinical partner's COVID-19 vaccination requirement. Approval for an exemption is dependent on the clinical site. Refer [online](#) for the detailed online immunization exemption process.

Nursing Essential Skills and Functional Abilities

[Nursing Essential Skills and Functional Abilities](#) are the essential functions every nursing student is expected to perform and are necessary for successful participation in the ADN program. This form will be completed online at the time the application is submitted. These are necessary to provide safe, ethical, and legal healthcare services. Students participating in the ADN Program are expected to demonstrate the essential functions listed in this form, with or without reasonable accommodation. These are applicable in classrooms, laboratories, and clinical settings. The nursing program uses independent clinical education sites that may or may not be able to offer the same reasonable accommodations that are made available by the College. Any student wishing to request reasonable accommodations due to a documented disability must initiate the [process for requesting student accommodations](#).

Non-Academic Criteria Continued

Background Check – COMPLETED UPON ACCEPTANCE INTO THE ASSOCIATE DEGREE OF NURSING PROGRAM

The completion of a criminal background check is one of the admission requirements to the Associate Degree of Nursing program. Specific requirements in regards to the background check will be given at orientation. The background check is required to ascertain:

- 1) The ability of students to eventually become licensed in the profession **AND**
- 2) The ability of students to attend mandatory clinical rotations at external facilities in accordance with the requirements of the program.

Because a criminal history can have different effects at the educational, licensure, and employment levels, when a person is considering pursuing a nursing career, it is best to have as much information as possible prior to deciding to enroll in a nursing program. Manhattan Tech encourages individuals who have criminal histories and who are interested in pursuing a nursing career to:

- 1) Contact approved nursing education programs and ask about the programs' enrollment criteria with respect to criminal convictions;
- 2) Review the criminal history information according to the [Kansas Board of Nursing policy 65-1120*](#); **AND**
- 3) Contact healthcare facilities and inquire about hiring criteria with respect to criminal convictions.

****This regulation deems certain criminal convictions could result in denial or restriction of access to a Kansas nursing license. If you have any questions regarding criminal convictions, contact the [Kansas Board of Nursing](#) for additional clarification.***

Acceptance Process

Admission to the MATC Associate Degree of Nursing program is determined through a competitive selection process. Submission of an application does not guarantee acceptance in the program. [Refer to page nine \(9\)](#) for the Associate Degree of Nursing Scoring Rubric. Priority status for admission will be given each August to the recent MATC PN graduating class, if they meet the Admission requirements. If there are spots available after accepting the current MATC PN graduating class for August, then ADN Transfer-In application packets will be considered.

If you are admitted into the Associate Degree Nursing (ADN) program without having all required prerequisite courses completed at the time of the application deadline, you will be required to have the remaining prerequisite courses completed with a "C" (2.0) or better before the ADN program starts. Official transcripts will need to be submitted to the Registrar for these courses. This also applies to those who are placed on the alternate list and then asked to join the ADN program.

After the application deadline, completed files will be scored utilizing the [Associate Degree of Nursing scoring rubric](#) and applicants will be notified of their acceptance, alternate, or denied status. **Notification will be emailed via MATC email the first week of November for spring (January) start date and first week of March for fall (August) start date.** Students should make sure the MATC email is working for application status. This is the main form of communication for the college.

Applicants offered a seat in the program must complete an online letter of intent indicating their plan to accept or decline enrollment in the nursing program by the date designated in the notification. In addition, a non-refundable \$100 deposit must be paid when accepting a seat in the program and will be applied toward program tuition and fees at the start of classes. A student choosing to defer or withdraw their intention will forfeit their deposit. **Failure to respond will result in forfeiture of a seat in the Associate Degree of Nursing Program.**

Student Responsibilities Upon Acceptance

After acceptance to the program, students will be required to attend program orientation (**generally held in November for January entry, and in May for August entry**). Students will be notified of the date and time of the orientation in the acceptance letter.

Specific information about the bulleted requirements below will be provided at orientation and will need to be completed by the first day of classes. Please do not submit TB skin tests before you receive information at orientation. Students are also required to provide documentation of the following items prior to the first day of class:

- ✓ **Electronic devices***. Laptops are required for the program. Windows-based devices are preferred.
- ✓ **Comprehensive Physical Exam** — Along with meeting all the Nursing Essential Skills and Functional Abilities, a ‘Physical Exam’ form will be provided at orientation. Students are required to obtain a physical exam within one (1) year before the start date to verify that there are no major health issues that may affect full participation in the Associate Degree of Nursing program and the clinical and lab exercises.
- ✓ **TB Skin Test (one or two may be needed)** — Students are required to have a TB Skin test performed and provide documentation of the test results. Information provided at orientation.
- ✓ **BLS certification**— Students must have a Healthcare Provider Level BLS certification from American Heart Association that will be active (not expire) throughout the nursing program. **Red Cross BLS certification is not accepted.**
- ✓ **Background Check** — <http://scholar.verifiedcredentials.com/?organization=matc> (The student is responsible for the additional fee).
- ✓ **Drug Testing** - Verification of a negative drug screen is required by the college’s clinical partners for the student to participate in the clinical portion of the nursing programs. (The student is responsible for the additional fee).
- ✓ **Health insurance**—students are required to hold health insurance during their enrollment at MATC in the nursing program.

Failure to provide the items listed above may result in dismissal from the program.

Electronic Requirements Upon Acceptance*

All ADN students are required to own and bring a **laptop** to class that meets the following criteria:

- Operating System - Microsoft Windows 10, Apple OSX 10.14 Mojave, or Ubuntu 20.04 LTS or newer
- Processor/Memory - Intel Core i5 or AMD Ryzen or better, 8GB of RAM for typical use
- Microsoft Office is required; MATC provides this software package to students enrolled in full time programs. Find out how to get yours [HERE](#).

System Requirements to View Manhattan Tech Courses – ADN Program

In order to view the necessary components of MATC courses, it is vital that the following items be functioning on your computer. Please keep the following information in mind:

- **Laptop:** Window 10 recommended
- Chromebooks and tablets are **NOT** supported by the testing environment software
- Browser - We recommend a browser such as Mozilla Firefox or Google Chrome
- Internet Connection: cable or DSL highly recommended; accessible and reliable connection necessary

Reapplication

Applicants who are not selected for admission are encouraged to submit a new Associate Degree of Nursing packet for the following year. Manhattan Area Technical College Admissions Applications are good for three (3) years. Those not selected for admission are encouraged to discuss increasing their rubric scores with their advisor.

Associate Degree of Nursing Transfer-In Admissions Scoring Rubric

Since the Associate Degree of Nursing program is a selective admission program, the scoring rubric (located below) will be used to determine the applicants selected. Any tiebreaker will be based upon the ATI Anatomy & Physiology Assessment overall test score. **Additionally, students must score a valid score in each area of the rubric below to be considered for priority admission into the program. N/A is not considered a valid score. If an applicant does not have a score on a particular row, then the student does not qualify for priority admission and their application will be reviewed on a case-by-case basis.** Students who do not qualify for admission are encouraged to follow up with an academic advisor to see what they can do to improve their scores.

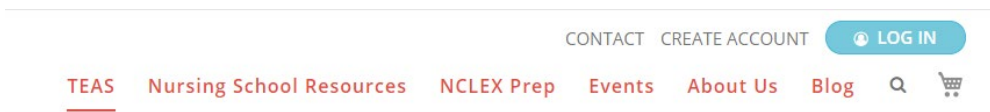

Explanation of Immunization Requirements

All immunizations below need to be completed and submitted with the selective admission application.
Religious or Medical Exemption procedures are noted on [HERE](#).

Refer to the [CDC's Recommended Child and Adolescent Immunization Schedule](#) for additional guidance.

MMR (Measles/Rubeola, Mumps, & Rubella)

Options to meet this requirement:

1. Provide a copy of proof showing a positive IgG antibody titer for Measles/Rubeola, Mumps and Rubella.
 - a. If the titer results are POSITIVE, attach a copy of the lab results to the nursing admissions application.
 - b. If any of the titer results are NEGATIVE or EQUIVOCAL, you must get your MMR series. After the first shot you will be required to complete the second MMR after 28 days and submit proof to Manhattan Tech.

OR

2. Show proof of or complete one series of MMR immunizations. One "series" of immunizations includes immunization for each disease on separate dates at least 28 days apart.

Varicella (Chickenpox)

Options to meet this requirement:

1. Provide a copy of proof of positive IgG antibody titer for Varicella
 - a. If the titer results are POSITIVE, attach a copy of the lab results to the nursing admissions application.
 - b. If the titer results are NEGATIVE or EQUIVOCAL, you must get your first Varicella vaccination and the second Varicella must be completed after 30 days and submit proof to Manhattan Tech.

OR

2. Show proof of or complete one series of Varicella immunizations. One "series" of immunizations includes two shots separated at least 30 days apart.

Tetanus/Diphtheria/Pertussis (Tdap)

Options to meet this requirement:

1. You must provide proof of Tdap vaccination, followed by a Tdap booster every 10 years.

Hepatitis B (Hep B) - Series could take up to 6 months to complete so plan accordingly.

Options to meet this requirement:

1. Provide a copy of proof showing a positive IgG antibody titer for Hep B.
 - a. If the titer results are POSITIVE, attach a copy of the lab results to the nursing admissions application.
 - b. If the titer results are NEGATIVE or EQUIVOCAL, you must get your Hep B series. You must obtain the first injection, then the second injection is given 1 to 2 months after the first dose, and the third injection is 4 to 6 months after the first dose.

OR

2. Show proof of or complete one series of Hep B immunizations. You must obtain the first injection then the second injection is given 1 to 2 months after the first dose, and the third injection is 4 to 6 months after the first dose.

COVID-19 Dose(s)

Options to meet this requirement:

1. Pfizer-BioNTech COVID-19 Vaccine series of two doses 3 weeks (21 days) apart

OR

2. Moderna COVID-19 Vaccine series of two doses 1 month (28 days) apart

OR

3. Janssen COVID-19 Vaccine single dose

Motor	Sufficient motor ability to execute the movement and skills required for safe and effective care and/or emergency treatment.	<ul style="list-style-type: none"> • Standing for long periods of time (8-12 hrs./day) • Lifting up to 50 lbs. • Performing one person and/or two-person transfers • Turning, log rolling, and ambulating another person • Manipulating equipment • Performing patient care procedures with finger and manual dexterity (i.e., starting IVs, phlebotomy, dressing changes, catheterization)
Intellectual	Ability to collect, interpret, and integrate information and make decisions. Ability to read and interpret the English language without assistance.	<ul style="list-style-type: none"> • Transcribe orders from a chart, interpret the orders, and intervene • Display critical thinking abilities in planning patient care- analyze data, formulate a diagnosis, and prioritize care
Behavioral and Social Attributes	Possess the emotional health and stability required for full utilization of the student's intellectual abilities, the exercise of good judgment, the prompt completion of all academic and patient care responsibilities, and the development of mature, sensitive, and effective relationships with clients and other members of the healthcare team. Possess the ability to tolerate taxing workloads, function effectively under stress, adapt to changing environments, display flexibility, and learn to function in the face of uncertainties inherent in clinical/practicum settings with patients. Possess compassion, integrity, concern for others, and motivation. Possess the ability to demonstrate professional behaviors and a strong work ethic and respect professional boundaries.	<ul style="list-style-type: none"> • Utilize intellectual abilities • Exercise good judgment and complete tasks within required time limits • Demonstrate the emotional health required for full utilization of intellectual abilities and exercise of good judgment • Show integrity, concern for others, interpersonal skills, interest, and motivation
